Annual Scientific Meeting Overview

In 2022, the High Blood Pressure Research Council of Australia held its first face to face meeting since 2019 APCH. The meeting was held at Melbourne Business School, Carlton.

This meeting took place in-person only on the 7th, 8th, and 9th of December with additional events and symposiums held outside of the main meeting. The ASM program was created once again by our amazing Joint Program Managers A/Prof. Francine Marques and Dr. Bradley Broughton, with the addition of Dr Quynh Dinh pictured below.

A total of 81 abstracts overall, including invited speakers, were submitted for the meeting from the following locations:

Feedback received from the meeting attendees via the evaluation confirmed 100% of responders would prefer a face-to-face meeting in the future with 15% of these requesting a hybrid option. 92% of responders are likely to attend future HBPRCA Annual Scientific Meetings.

Some stand out points that were mentioned included the communication received regarding the meeting, the awards reception, the Women in hypertension session and of course the meeting being face to face to mention a few. There is also a strong appetite to hold joint meetings in the future to provide more variety and increased attendees.

Our invited speakers included:

Prof. Tazeen Jafar (Duke-NUS Medical School, Singapore) who delivered the R.D. Wright Lecture Innovative health systems solutions for addressing global disparities in hypertension control; Prof. Rebecca Ritchie (Monash University) presented the Colin Johnston Lecture Insights into protecting the function of the heart - the round-trip journey from patients to cells through to preclinical models back to human heart failure.

Prof. Laura Mackay (University of Melbourne) gave the Austin Doyle Lecture Tissue-Specific *Immunity*;

Professor Geoff Head (Baker Heart & Diabetes Institute), the 2021 Paul Korner Awardee, presentation detailed the breadth of his work on Novel mechanisms for sympathetic activation in hypertension.

Meeting Highlights

The Arterial Pulse in Health and Disease: A Festschrift for Professor Michael O'Rourke and Professor Wilmer Nichols

A hybrid symposium was held on 18 November 2022 on zoom and in person at St Vincent's Hospital Campus Sydney. The symposium was in celebration of the lifelong achievements in arterial haemodynamics of Michael O'Rourke and Wilmer Nichols. Their work has been at the forefront of the applications of the pulsatile function of arterial blood pressure and flow in understanding the physical principles underlying the normal and abnormal manifestation of the arterial pulse.

The symposium also commemorates the 60th anniversary of McDonald's "Blood Flow in Arteries" and the release of the book's highly anticipated 7th edition. Apart from the first two editions (1960, 1974), all editions have been curated and edited by Nichols and O'Rourke

Pressure Wise – in partnership with the Heart Foundation

Pressure Wise is an excellent initiative of the Public Engagement portfolio, headed by Dr. Rachel Climie, and the ECR Committee. The free community event which was held on Tuesday the 6th of December had 21 participants and focused on improving the knowledge of blood pressure and heart health in the general community.

The high calibre of speakers included Prof. Claire Collins, Prof. Jim Sharman. Ms Saloni Shah, Dr Martin Schultz and Dr. Lisa Murphy. The session was chaired by Prof. Markus Schlaich and covered the following topics:

- What is high blood pressure and what are the risk factors for developing it?
- What is the best diet to eat for healthy blood pressure?
- What is the best activity to do for healthy blood pressure?
- What is a Heart Health Check?
- What has blood pressure got to do with stroke?

Members of the public were welcomed to join in and ask questions to our high blood pressure experts in the designated panel.

The session was well received by the attendees and generated some great discussion.

Our 2022 HBPRCA keynote and invited name lecturers delivered a plethora of important and engaging presentations that were highly received by this year's attendees. All of our invited speakers were captivating and we were very fortunate to hear from the following HBPRCA keynote invited named lecturers:

The 2022 RD Wright Lecture was given by Professor Tazeen Jafar of Duke-NUS Medical School Singapore. Professor Jafar's presentation, Innovative Health Systems Solutions for Addressing Global Disparities in Hypertension Control was extremely well received by all.

The 2022 Austin E Doyle Lecture was given by **Professor Laura Mackay** of the University of Melbourne. Professor Mackay's presentation Tissue-Specific Immunity was fascinating and enjoyed by all.

The 2022 Colin I Johnston Lecture was given by Professor Rebecca Ritchie of Monash University. Professor Ritchie's presentation *Insights into protecting the function of the heart* - the round-trip journey from patients to cells through to preclinical models back to human heart failure was very well received.

The 2021 Paul Korner Medal Awardee Professor Geoff Head was invited to speak as a recognised senior scientist who is an active researcher and has made a significant contribution to high blood pressure and the HBPRCA. He shared his wisdom on: Novel mechanisms for sympathetic activation in hypertension.

HBPRCA were pleased to receive a splendid lecture from the 2021 American Hypertension Association (AHA) award winner Dr Stephen Juraschek of Harvard Medical School in the USA. Dr Juraschek gave a highly engaging presentation on Orthostatic Hypotension in Adults with Hypertension: A Complex Union.

We are delighted the 2021 British and Irish Hypertension Society (BIHS) winner, Dr Luca Faconti from King's College London was able to attend. Dr Faconti's presentation on Preload reduction augments the early phase of left ventricular contraction and improves diastolic function in hypertension was well appreciated.

HBPRCA Awards 2022

A host of talent within HBPRCA membership was again recognised and rewarded in 2022 including the presentation of a range of oral and poster awards. A hearty congratulations goes out to all the worthy recipients below.

The Robert Vandongen award:

The Robert Vandongen award is presented for the highest scoring abstract submitted by a member from Western Australia.

The 2022 Robert Vandongen award went to **Prof. Markus Schlaich from University of Western Australia.**

The Judith Whitworth award:

Prof Judith Whitworth was the first woman to be elected as the president of the HBPRCA (1999-2001). Throughout her career, Prof Whitworth not only contributed to a major way to high blood pressure research herself, and to the mechanisms involved in steroid-related hypertension, but broke numerous barriers and paved a path for women in research, clinical practice and policy making. The Judith Whitworth award goes to the highest ranked HBPRCA member abstract for which the first author is a woman.

The 2022 Judith Whitworth award winner was **Dr Bhavisha Bakrania** from the University of





The Jaye Chin-Dusting Mid-Career Scientist award:

Prof Jaye Chin-Dusting was the second woman to be elected as the president of the HBPRCA (2011-2016). As a founder of the Australian Cardiovascular Alliance, Prof Chin-Dusting was deeply concerned with the funding available for cardiovascular disease, which affects particularly those in the early- and mid-stages of their career. During her presidency of the

HBPRCA, she also established the young investigator subcommittee of the HBPRCA, to improve training, networking, and opportunities for early and mid-career high blood pressure researchers.

A mid-career scientist (between 5-20 years post PhD) who is an active researcher will receive the Jaye Chin-Dusting Award. The 2022 Winner of the Jaye Chin-Dusting Mid-Career Scientist in High Blood Pressure Research award went to **Dr Antony (Bill) Vinh** of La Trobe

University.



The Paul Korner Senior Scientist in High Blood Pressure Research award:

Prof Paul Korner was one of the founders and a former president of the HBPRCA (1987-1989). He devoted a large part of his career to researching the causes of essential hypertension, with a special focus on underlying neural and cardiovascular mechanisms. A senior scientist (>20 years post-PhD) who is an active researcher and has made a significant contribution to high blood pressure and the HBPRCA receives the Paul Korner Senior Scientist in High Blood Pressure Research Medal.

This year's worthy recipient is **Prof. Lawrie Beilin** from the University of Western Australia.

Student and Early Career Researcher Awards:


2022 saw a great range of high-quality Student and Early Career Research oral and poster submissions. The effort in their work have been appreciated by all, and congratulations extend to the following winners:
